



Price list for IdoSell Booking services in GBP & EUR

Effective from the 1st of September 2016 until its cancellation.

Settlement currency: GBP or EUR. All prices are net prices; to obtain a gross price on the territory of European Union countries, one shall add VAT at 23%. Companies from outside the EU, but settling VAT in the EU, have their invoices issued without VAT.

1 – Subscription models

1. **Commission-based model – £9 / 9€ per one-year subscription + 1% commission charged for all online reservations.**

Commission is calculated from the total value of each reservation made via the Booking Widget or one of the integrated services (integrated either as a Booking Partner or via the Channel Manager). The value of commission always amounts to 1% of the reservation price. It is charged either when an advance payment is made or after the reservation ends, even if no payment has been recorded in the administrative panel. Exceptions:

1. If the selected payment method is a wire transfer made to the Client's bank account, full commission is charged, unless the client marks the reservation as cancelled by changing its status in the administration panel.
2. No commission is charged for reservations added manually via the administration panel or the mobile application.
3. If the Client is found to manipulate bookings to avoid paying the commission, the Operator has the right to acknowledge all suspicious bookings as a violation of the terms and conditions and charge an appropriate commission.

2. **Flat fee model – £250 / 299€ per one-year subscription**

The model includes the same scope of services as the commission based model with the exception of the Channel Manager function.

3. **Flat fee model including Channel Manager – £500 / 599€ per one-year subscription**

The model includes the same scope of services as the commission based model.

4. If the Client decides opts for a flat fee model, one-year subscription fee is charged in advance and there are no additional charges as described in section 1.1.
5. The Client is able to change from the flat fee model to the commission-based model by notifying the Operator at least 30 days before the end of the one-year subscription period.
 1. If the Client does not inform about the wish to change the subscription model at least 30 days before the end of the subscription period, their current subscription model will be automatically extended for the next year.
 2. While the one-year flat fee subscription is still valid, the Client has the right to resign from or change the subscription model (i.e. change the subscription model described in 1.2. to the model outlined in 1.3) by making a payment for the remaining period of the flat fee subscription. In such a situation, the amount paid for the previous subscription plan is non-refundable.

2 – Fees for additional services

1. **Comprehensive service configuration - £100/120€**

This service includes service configuration on behalf of the Client. The configuration consists of adjusting the administration panel settings, creating an offer description based on the information provided by the Client, preparing a free website and embedding the Booking Widget on the Client's



website and Facebook profile (if the Client agrees to provide the access necessary to edit such websites). If the Client decides within 30 days to display the IdoSell Booking website under their own domain, the cost of the configuration is returned to the CSC balance.

2. One working hour of the graphic designer team on tasks related to the Service - £30/35€

The price covers the cost of one working hour of a specialist spent in rendering following services: IdoSell Booking webpage design, logo design and vectorization, preparation of translations, administration panel configuration, transfer of data from external services (including other reservation management systems), unusual server configuration, i.e., domain redirection.

3 – License for fields of exploitation other than IdoSell Booking

Graphic designs can be used without purchasing any license on websites connected with the Service. If the Client wants to use the works on fields of exploitation other than IdoSell Booking, they have to purchase a license for transfer of property rights. Assets not listed below (i.e. e-mail templates, HTML and JavaScript addons, Banners and Buttons) do not require purchasing additional licenses.

1. Written logo license – £29 / 34€

Logos designed by our graphic artists are included in the license to be used under IdoSell Booking. An exclusive license with the transfer of intellectual property rights allows the logo to be used anywhere. The fee includes a written, exclusive license with the transfer of property rights. If the logo was designed as part of the Showcase page design process we allow it to be used it exclusively on websites connected with the Service. If the Client wants to use the logo in a field of exploitation other than IdoSell Booking, they have to purchase the transfer of intellectual property rights.

The fee covers the issuance and transfer of an exclusive license for 1 logo as a PDF file, signed with a qualified digital signature, and does not include the cost of preparation and vectorization of graphics, such works have to be commissioned as additional graphical design tasks, payable on general terms or independently by the Client. If the Client wishes to receive the license on paper, they have to order an additional service: Mail delivery on the territory of Europe.

2. Written Template design license – £300 / 350€

The fee covers providing the Template design in PSD format with permission to freely modify the artwork and implement it outside the IdoSell Booking service. The license is exclusive and includes the permission for custom Template modifications by the Client.

3. Written Showcase page template license – £1000 / 1200€

The fee covers providing the Showcase page template together with its design and source code (JavaScript, CSS) of related page elements.. The license is non-exclusive and includes the permission for custom Template modifications by the Client.

4 – Other fees

1. Mail delivery on the territory of Europe – £4/4,50€

The service covers sending any mail to the Client, in physical form (e.g. a paper copy of an invoice with weight up to 350 grams) when the document provided electronically with a qualified digital signature is not sufficient for the Client. The cost covers dispatch of a registered letter on the territory of Europe (including Cyprus, Russia and Israel).

2. Cession – £10/15€

3. Return of Balance surplus – £6/8€

It is possible to have surplus in the Balance. The fee covers costs of issuance and dispatch of a correction invoice and, when it is sent back, of processing a bank transfer into the Client's bank account registered in a Polish bank or via an Internet payment system where the payee bears costs of the commission for the transfer.

4. **Fee for withdrawing funds accumulated in the CSC Balance to the indicated bank account - £0,2/0,2€**
 5. **Fee for transferring funds accumulated in the CSC to the Balance - £0/0€**
 6. **Fee for making a payment to the CSC Balance via PayPal - consistent with the commission charged by PayPal Inc.**

The fee is charged when, instead of making a wire transfer, the Client decides to make a payment to the Balance via PayPal. The payer is charged with the transaction fee in form of a deduction from the Balance in a separate transaction.

7. **Fee for making a payment to the CSC Balance via instant payments operated by IdoSell Booking – 1% of the transaction value**

The fee is charged when, instead of making a wire transfer, the Client decides to make a payment to the Balance via the instant payment system operated by IAI. This does not refer to a transfer from the CSC Balance or a transfer related to payment to courier upon delivery. The payer is charged with the transaction fee in form of a deduction from the Balance in a separate transaction.

8. **Booking Partner commission – consistent with the commission specified by a Booking Partner**

Commission is charged by the Booking Partner for acquiring an order for the Client. The client is informed about the amount of commission while accepting the terms of a given Booking Partner.

Appendix 1 – PayPal handling fees for international transactions

International PayPal payments, including also credit cards processing, are available for the Client regardless the location. The commission charged for PayPal payments:

- 1.For bookings made from Poland – 2,1% commission + 0,80 PLN handling fee.
- 2.For bookings made from other countries – 2,5% commission + a handling fee specified below.
- 3.Commission is not charged in case of processing transactions via own PayPal account.
