1 – Administration fees

1. **Activation fee – £149 / 169€**
Charged one time for installation of independent Administration Panel.
2. **Activation fee for additional shop – £25 / 29€**
Charged one time activation of each additional shop installed to already existing Administration Panel.
3. **Dedicated Virtual Server preparation fee – £69 / 79€**
Fee charged for activation of Service in DEDICATED CLOUD subscription plan. It covers the preparation of Dedicated Virtual Server and transfer of Service data from Shared Server in a manner that should not result in any shutdowns, in term agreed with the Customer.
This service is also available in Express mode – £100 / 115€
4. **Change of Dedicated Virtual Server parameters fee – £69 / 79€**
It covers the change of one of the subscription plans – DEDICATED CLOUD – to a different Dedicated plan. If it is necessary, the fee covers all activities related to relocation of Customer's virtual machine and its reconfiguration with new parameters.
This service is also available in Express mode – £100 / 115€
5. **Change of Dedicated Virtual Server parameters fee, made in 14 days from the last change – £3 / 4€**
It covers the cost of fulfilling the service, described in 1.3 and 1.4 point of present Price List, in 14 days from performing the task of server change.
6. **Migration from the Dedicated Server to a Shared Server fee – £69 / 79€**
It covers the Shared Server preparation and transfer of Service data from Dedicated Virtual Server to Shared Server in a manner that should not result in any shutdowns, in term agreed with the Customer.
7. **Removal and creation of backup copy of administration panel as a result of arrears in payments – £175 / 200€**
One-time fee, charged when at least one invoice exceeds its maturity date by 60 days or Minimal Balance has been exceeded, not fed for more than 60 days and there had been no reaction on written summons or scheduled payments. Fee covers uninstallation, creation of backup copies of one administration panel for a period of six months or until vindication procedures end and deletion of all data after this time.
8. **Cession – £9 / 14€**
9. **Balance surplus withdrawal fee – £6 / 8€**
It is possible to withdraw the Balance surplus. The fee covers the handling costs for operation of issuing and sending the corrective invoice and – after dispatching it – the money transfer to the, pointed by the Customer, bank account in Polish bank or other Internet payment system in which the receiver bears the cost of commission fee.
10. **Providing information about our customer's business within our service to the police, a prosecutor's office, other supervisory body or law enforcement agencies upon receiving a summons - £7,5 / 8€**
If a shop's customer reports crime to the police or a prosecutor's office, or if supervisory body requires information regarding our customer, the operator is obliged to provide the required information. The cost is calculated from each case identified by the file reference number.

2. **DEDICATED CLOUD 1 (DC1) subscription plan – £84 / 96€**

Monthly fee with no Additional Fees for Transfer, number of Visits, API Calls or number of products.

The only limit is the Dedicated Virtual Server capacity.

Functionality: full functionality of the IdoSell.com without any quantitative limits in modules.

Administration and updated of Dedicated Virtual Server are included in fee.

DC1 Dedicated Virtual Server has: 1 processor core, 3000MB RAM, 80GB of disc space and a network connection with nominal bandwidth of 1Gbps without transfer limit.

3. **DEDICATED CLOUD 2 (DC2) subscription plan – £135 / 155€**

Monthly fee which includes the same scope of services as in DEDICATED CLOUD 1 plan and a following Dedicated Virtual Server parameters: 2 processor cores, 6000MB RAM, 100GB of disc space and a network connection with nominal bandwidth of 1Gbps without transfer limit.

4. **DEDICATED CLOUD 4 (DC4) subscription plan – £187 / 214€**

Monthly fee which includes the same scope of services as in DEDICATED CLOUD 1 plan and a following Dedicated Virtual Server parameters: 4 processor cores, 12000MB RAM, 100GB of disc space and a network connection with nominal bandwidth of 1Gbps without transfer limit.

5. **DEDICATED CLOUD 8 (DC8) subscription plan – £337 / 385€**

Monthly fee which includes the same scope of services as in DEDICATED CLOUD 16 plan and transmission performed by three parallel servers with parameters exactly as in DC 16 subscription plan.

1. **Additional Fee for each started 1GB of Transfer beyond the CLOUD limit – £0,13 / 0,15€**

The fee does not change the Transfer Limit.

4 – Maintenance works

1. **Working hour cost of data import – £25 / 29€**
Working hour of editing the Customer's data or developing an application dedicated to data import from external database, including a different on-line shop.
This service is also available in Express Mode – £17,5 / 20€ for every started half of hour.
2. **Working hour cost of programmers team – £25 / 29€**
Working hour cost of writing a new function of application or analyzing code of program sent by Customer.
This service is also available in Express Mode – £17,5 / 20€ for every started half of hour.
3. **Working hour cost of training – performed in the training location – concerning handling sales based on the IdoSell.com – £25 / 29€**
It includes training in the Provider's headquarters or performed remotely Training covers running the e-commerce enterprise, on-line shop or handling the IdoSell.com (it does not include the access to technical support by phone or IdoSell.com Tickets), including remote system or supporting application configuration, and is intended for 1 to 6 persons – delegated by the Customer – at the same time. The fee does not include the costs of transportation bore by the Customer. Maximum time of training is 4 hours.
4. **Cost of server administrator working hour – £29 / 34€**
Working hour of server administrator who works trough untypical service works, for which reconfiguration of server or other services, installed on the Provider's servers, is necessary.
This service is also available in Express Mode – £19 / 24€ for every started half of hour.

5 – Graphical works

1. **Working hour cost of graphics team performing activities related to the Shop Mask – £25 / 29€**
Working hour of person performing modifications of the Customer's Shop Mask or auction templates. In case of works related to developing a new language version, the cost of translation and text preparation is not included. In such cases, the Customer should provide translation prepared by his own translator.
This service is also available in Express Mode – £17,5 / 20€ for every started half of hour.
2. **Working hour cost of graphics team performing other graphical works - £29 / 34€**
Working hour of person performing services for Customer, covering creating graphical elements such as: press advertisements, retouch and other graphical services not directly related to modifications of Shop Mask or other services related to creating Flash objects or other for which a specialistic software is necessary.
This service is also available in Express Mode – £19 / 24€ for every started half of hour.
3. **BASIC Graphics Package – £399 / 469€**
It includes 18 working hours of graphics team needed for preparation of page design and Shop Mask coding, based on project in the PSD format. In case of providing a shop project prepared by the Customer, the entire time is used for coding and – if it is not used in full – it can be used for other graphical services.
4. **ADVANCED Graphics Package – £789 / 899€**
It covers the same scope of services as in the BASIC graphics package, but it includes 35 working hours of graphics team.



5. **SOPHISTICATED Graphics Package – £1349 / 1549€**

It covers the same scope of services as in the BASIC graphics package, but it includes 60 working hours of graphics team.

6. **SUPREME Graphics Package – £2249 / 2569€**

It covers the same scope of services as in the BASIC graphics package, but it includes 100 working hours of graphics team.

7. **Drawing a written license for logo – £25 / 29€**

Logos created by our graphic designers are used – within the scope of license – in the IdoSell.com shops. Obtaining exclusive license conveying the copyright laws and property rights to the Customer allows for registering the trademark and disposing it freely. The fee covers granting a written, exclusive license conveying the property rights. If – within the scope of fee for preparation of shop project – a logo was also created, The Provider allows only for using it on the pages directly related to the Service. If the Customer would like to use this logo in materials other than the shop page, he should purchase the convey of property rights.

The fee covers drawing and sending the PDF document, signed with qualified digital signature, which contains a exclusive license for 1 trademark and it does not include the cost of preparation and vectorization of this graphic. These works need to be performed as a additional graphical works, billable on general grounds, or performed by the Customer himself. Sending this license as a printed document demands a additional Consignment in Europe service.

7 – IdoSell.com Supporting Applications

To run the selected Supporting Application necessary is: a personal computer with Windows operating system and up-to-date .NET software environment. Paid Supporting Applications allow for ordering demo license keys and testing the software prior to purchasing it. The fees include license for 365 days with support for multiple (unlimited) computer stations connected to one Administration Panel, free updates and technical support. Licenses for integrating applications do not cover the cost of license for applications of Third Parties or costs of access to suppliers databases, which should be obtained individually. License of “prolongation” type are extending the license for another 365 days and are available in case of ordering the application not longer than 30 days after the expiration of the former license key. In case of the license for IAI Scanner the cost of the license includes one device using the application for 24h. If a customer wants to use the application on more than one device there is a need to buy as many licenses as devices using IAI Scanner within 24h.

8 – Additional services

Additional services are optional, not obligatory modules modifying the standard, free-from-charge Service behavior. White-Label, Premium IP and Company Branch services have – in the first month of use – fees calculated proportionally to number of days until the end of the month and – in the next months – in advance for every started month. Service is established and the fee charged for every Shop Mask separately, independently from the subscription plan.

1. **White-Label service – £50 / 57€**
It allows for removing the “Powered by IdoSell.com” logo, alternative text, link from the Shop Mask and Meta-Author section.
2. **Premium IP service – £6,25 / 7,5€**
It allows for running the Shop Mask on separate IPv4 address. This service is necessary to install the Customer's SSL certificate. The Provider shall have the right to refuse to fulfill this service in case of lack of free IPv4 addresses.
3. **Company Branch service for CLOUD subscription plan – £6,25 / 7,5€**
It allows for supporting an additional Shop Mask with separate Billing Details for selling company and support for these details also in selling documents.
4. **Company Branch service for subscription plans other than CLOUD – £18,75 / 22,5€**
It covers the same functionalities as a the Company Branch service for CLOUD subscription plan but for other subscription plans.
5. **Export Generation Pro service – £2,25 / 2,75€**
Allows to generate offer files for purposes of integration with external sites (i.e. price comparers) at indicated hour, not more than once every 4 hours. Service available only for DEDICATED CLOUD plans. Fee is charged for every store separately.
6. **E-Mail Marketing Pro (for subscription plans other than CLOUD) – £9,75 / 11€**
Allows to send personalized newsletters, triggered messages and perform many other advanced e-mail marketing operations. Service available only for DEDICATED CLOUD plans. Fee is charged for administration panel. Minimal term of notice is 14 days.
7. **Consignment in Europe – £4 / 4,50€**
It covers sending of any consignment to the Customer in a material form, i.e. paper invoice copy (with weight up to 350 grams), in situations when the Customer needs something else than a electronic document, signed with qualified digital signature. The cost covers sending a registered mail to any of the European countries (including Cyprus, Russia and Israel).



8. **Fee for withdrawal of funds from CSC to a specified bank account in SEPA– £1,5 / 1,75€**
9. **Fee for transfer of funds from CSC to Balance – £0 / 0€**
10. **Fee for payment made to Balance by means of PayPal instant payments system – compliant with current PayPal commissions**
Fee charged, when Customer decides to pay funds to Balance by means of PayPal system, instead of a standard bank transfer. This fee paid by payer – operation is performed by deducting funds from current Balance.
11. **Fee for payment made to Balance by means of by IAI payment system – 2% of transaction value**
Fee charged, when Customer decides to pay funds to Balance by means of “by IAI” instant payment systems, instead of a standard bank transfer. It does not include transfer of funds on CSC Balance or money from cash-on-delivery courier services. This fee paid by payer – operation is performed by deducting funds from current Balance made in additional operation.

Appendix no. 1 – SMS and E-mail Price List

Provider allows to send SMS. Texts longer than standard limits are divided into multiple messages. Branded messages allow to change content of 11-character-long Sender field – Customer name will be displayed. Priority messages are always sent within 3 minutes. SMS are cleared on daily basis as a sum of costs of messages sent on particular day.

Their servers have a very high delivery rate, because of good reputation, so they can deliver e-mails even to free e-mail accounts and report bounces (so-called Soft and Hard Bounces). In addition, sending process does not load the customer's server. Newsletters sent by Freshmail have full functionality of the E-mail Marketing Pro service completely for free.



Appendix no. 2 – SSL Certificates Price List

Provider offers possibility of using SSL certificates to secure all transmissions with SSL / HTTPS protocol. SSL-related services below can be used under any subscription plan. Provider allows to upload SSL certificates purchased beyond the Service. Using other certificates other than those mentioned below requires using Premium IP service.

SSL certificates are issued by CERTUM PCC (Unizeto Technologies S.A.) and are compliant with international standard confirmed by WebTrust™ certificate. It guarantees correct display of certificate. Provider offers full support and help in purchase of a SSL certificate. Certificates are issued for 1, 2 or 3 years and fee is charged for the entire period. Purchased certificates can be downloaded from the administration panel and used beyond the Service. Wildcard Certificates are the ones purchased for the domain with a prefix, *mydomain.co.uk (where * stands for any prefix).
